

PROTOCOL A

REFERRED TO IN SUB-PARAGRAPH (b) OF ARTICLE 2

PROCESSED AGRICULTURAL PRODUCTS

Article 1

1. In order to take account of differences in the cost of the agricultural raw materials incorporated in the products referred to in Article 2 of this Protocol, this Agreement does not preclude:

- (a) the levying, upon import, of a duty;
- (b) the application of measures adopted upon export.

2. The fixed duties, levied upon import, shall be based on, but not exceed, the differences between the domestic price and the world market price of the agricultural raw materials incorporated into the products concerned.

Article 2

1. For products listed in Table I, originating in Macedonia, Iceland, Liechtenstein/Switzerland and Norway respectively shall accord the concessions indicated in Table I.

2. Taking into account the provisions laid down in Article 1 of this Protocol, Iceland, Liechtenstein/Switzerland and Norway shall, based on reviews that can be held upon request, accord to products listed in Table I, originating in Macedonia, treatment not less favourable than that accorded to the European Community.

Article 3

For products listed in Table II, originating in an EFTA State, Macedonia shall accord treatment not less favourable than that accorded to the European Community.

Article 4

1. The EFTA States and Macedonia shall notify each other at an early stage, at least before the entering into force, of all measures applied under Article 1 of this Protocol.

2. Macedonia and the EFTA States shall inform each other of all changes in the treatment accorded to the European Community.

Article 5

The Parties shall review periodically the development of their trade in products covered by this Protocol. In the light of these reviews and taking into account the arrangements between the Parties in the WTO and between them and the European Community, the EFTA States and Macedonia shall decide on possible changes to the product coverage of this Protocol, as well as on a possible development of the measures applied under Article 1 of this Protocol.
